Monday, December 12th, 2016

Town Council Present: Mayor Steve Sproul, Councilmen Dick Claar, Owen Mathews, John Aloisio and Ben Glenn

The meeting was called to order by Mayor Steve Sproul at 7:03 p.m. with the Pledge of Allegiance being said.

Guests: Ron Caylor, Hopper's Bar, requested a catering permit for a Shriners event at the Hub Café on December 17th from 6 pm-12 am. **Councilman Claar motioned to approve the catering permit and Councilman Claar seconded. Motion passed 5/0.**

Heath Turbiville stated SLIB meeting is January 18 & 19th.



Councilman Glenn gave the Fire Dept report.


Jim Peck discussed PREC franchise agreement and the CCSD lease agreement for the use of the MTC gym.
