Visitor Louis Schelling representing the Moorcroft Senior Citizen Board asked that they receive \$3,000.00 this year to cover costs. Mayor Blakeman discussed that this month we will begin working on the budget.

Administrator Dan Blakeman gave a report. Blakeman reminded the Mayor and Council about the Retreat starting Friday, March 15, 2013 at 6:00 PM. Moorcroft will host the next County/Town Workshop March 27, 2013 at 6:30 PM.

Dan Blakeman gave the maintenance report. The second week in April the Town will start flushing hydrants. The Town will notify residents as it gets closer to time with some instructions, and they will see some discoloring of the water during this process. Administrator Blakeman provided the Mayor and Council with a spreadsheet showing when the landfill is most busy. After reviewing and discussing the spread sheet it was suggested that the landfill be open Tuesday, Friday, and Saturday. Councilman Devish motioned to change the landfill hours of operation to Tuesday 10:00 AM – 4:30 PM, Friday 10:00 AM – 4:30 PM and Saturday 9:00 AM – 3:00 PM Mathews 2nd all ayes, motion carried.
